

SEN Information Report for Fitzwilliam Primary School– in accordance with section 65(3) of the Children and Families Act 2014

1. What kind of Special Educational Needs provision is accessible for children at Fitzwilliam Primary School?

Fitzwilliam School is a fully inclusive school, which ensures that all pupils achieve their potential; personally, socially, emotionally and academically in all areas of the curriculum regardless of their gender, ethnicity, social background, religion, physical ability or educational need. The school provision map is outlined on the school's Local Offer.

2. How do we identify children who may have an SEN need?

- Children entering our nursery and reception are baselined according to the Early Years Framework and any needs are identified here.*
- Pupil progress meetings/discussion are every half term from which we track and identify children who are not making expected national progress. Interventions/support programmes are then implemented and monitored to ensure that the child makes accelerated progress.*
- Visually and Hearing-Impaired children will be known to the school through Wakefield's Visual and Hearing Impairment team. Those children attending the provision have specific assessments and targets set which are age appropriate.*
- School holds annual Planning Meetings and Consultations with a member of the School's Advisory Team from Wakefield Authority for both Early Years and Years 1-6. We also have Planning Meetings with our Trust Educational Psychologist. These meetings allow staff to share any concerns that they have in agreement with the parent and referral can be made.*

3. What provision is made for children with SEN; with and without an EHC Plan.-in respect of:

a) How is the intervention/support monitored as to its effectiveness?

Those children identified as benefiting from intervention/support are monitored against the progress they are making; this is normally taken into consideration each half term following assessments and at termly pupil progress meetings with the Head Teacher.

b) What are the school's arrangements for assessing and reviewing progress of children with SEN?

Progress is tracked through termly pupil progress meetings, through reviews with the external support agencies and the SENDCO tracks and advises on SMART targets termly according to the whole data collated through assessments, book scrutiny and observations. In addition to this school meets with parents at least three times a year to discuss the progress of their child during a Supporting Me To Learn Plan meeting with the class teacher and/or SENDCO.

c) What is the schools approach to teaching children with SEN?

We are a fully inclusive school, which ensures that all pupils achieve to their full potential, this may be through differentiation, small group work or through 1 to1 precision teaching.

d) How does the school adapt the curriculum and learning environment for children with SEN?

The curriculum and teaching sequences are adapted to meet the needs of the individual. The school takes all reasonable steps to modify/adapt the learning environment to meet the individual needs of children. (See Access Plan)

e) What additional support is available for children with SEN?

The school provides various interventions/support that meet the individual needs of the children (see Local Offer/Provision Map). Children who may require higher levels of support have access to appropriately trained support staff.

f) What support is available for ensuring the emotional and social development of pupils with SEN?

Children access a Trust designed curriculum that addresses our PSHE curriculum. School employs a Learning Mentor who will also support the emotional and social development of pupils with SEND with the support of external agencies when required.

5. What specific expertise is available to children with SEN?

- SENDCO has achieved the National Award for Special Educational Needs Coordination.*
- All staff delivering interventions are appropriately trained.*
- Teachers have received training based on Understanding Autism*
- School have access to a Trust Speech and Language Therapist.*
- School have access to a Trust Educational Psychologist.*

6. What specialist equipment and facilities are there for children with SEN?

- Occupational Therapy resources can be made available (slanting boards/cutlery/wobble cushions) following their observations and recommendations.*
- Load to Learn software for visually impaired children with a trained member of staff to produce adapted resources.*
- School has ramp access to two entrances at school as well as to each classroom.*
- School have access to Chrome Books that can be utilised to support all children in their learning, recording and develop independence.*
- School have two designated rooms to support children to work in quieter spaces, supported by a teaching assistant or the learning mentor.*
- School has disabled toilets and showers in both buildings.*

7. What arrangements are there for consulting and involving parents of children with SEN?

Parents are actively encouraged to be partners in their child's education through; informal discussions, telephone contact, SEN Plans/provision map discussions, progress reviews and yearly written reports.

8. What are the arrangements for consulting children with SEN about, and involving them in, their education?

All children are aware of their next steps in a way that is appropriate to them. Children who have additional needs have targets which are shared, discussed and worked upon with those members of staff who are providing their additional support.

9. What are the arrangements for parents of children with SEND who may wish to complain about the provision?

School has a Complaints Policy which parents are requested to follow if they wish to complain about provision. A copy of this policy is available upon request from the School Office. Parents who wish to complain are strongly encouraged to initially speak to the Head Teacher regarding their complaint. If the issue can't be resolved at this level or the complaint is regarding the Head Teacher the parent would be directed to the schools complaints procedure.

10. How does the school/governing body involve health, social services, LA Support Services, and others in meeting the needs of children with SEND and supporting their families?

In order to meet the individual needs of a child the school will work with and seek advice from an educational psychologist, advisory teacher, speech and language therapist or health colleague to support the child's academic and social progress. The school has a SEND governor who also works within the SEND framework in their workplace and is able to challenge and support the school SENCO to strive for excellence. The governing body receive regular updates from the SENDCO and SEND Governor in their regular meetings.

11. What are the school's arrangements for supporting children with SEND in transferring between phases of education?

- Consultation with parents/carers in how we can best meet the emotional needs of the child.*
- Consultation with teaching staff, support staff and other lead professionals as to how we can best support the academic, medical and social needs of the child.*
- Opportunities for the child and parent to have supported visit's to the new setting.*
